Invitation for Expression of Interest

The Aurangabad Smart City Development Corporation Limited (ASCDCL), Chhatrapati Sambhajinagar invites Expression of Interest (EOI) from duly interested, qualified advertising agencies for grant of advertisement rights on 50 Nos of Digital outdoor displays, already installed and operating at various strategic locations in Chhatrapati Sambhajinagar city on PPP basis.

Scope of Work:

- 1. Conduct site survey of DOD screens at own cost; ASCDCL will assist with permissions. No claims for misunderstanding accepted.
- 2. ASCDCL has installed 50 Digital Outdoor Display (DOD) screens at various locations across the city and is currently maintaining them. The selected bidder shall be responsible for installing additional DOD screens, if required, either at the existing locations or at new locations proposed by the bidder, which should be commercially and socially viable. The cost of installation for the new DOD screens shall be borne by the bidder, who will share a percentage of the generated revenue with ASCDCL.
- 3. Install minimum P6/P4 LED DODs (or better) as 10 ft x8 ft, 12 ft x 8 ft, or 10 ft x10 ft or bigger size as per requirement for greater visibility and impact and beautify the city look, ensuring better viewing distance greater than 10 m, with required infra.
- 4. Prepare, execute, and manage ad plans; maintain displays in clean, safe condition.
- 5. Pay electricity and network bills related to the DOD and DOD infra as required
- 6. Pay all applicable levies, and dues to authorities.
- 7. Promote DODs with cultural, social, tourism, and commercial content.
- 8. Display ASCDCL-approved social messages for 2 hours daily, extendable as needed.
- 9. Ensure all displayed content is legal and socially appropriate.
- 10. Provide online platform for ad space selection.
- 11. Upload content as per the bylaws of the Government.





- 12. License period is 15 years, extendable to 20 years by mutual agreement.
- 13. Conduct structural audits of all the installations once every three years.
- 14. This project shall be executed under a Public-Private-Partnership model. The revenue generated through commercial advertisements shall be shared between the advertising agency and ASCDCL as per the following terms:
 - The Advertising Agency shall pay the Authority a fixed percentage of the gross monthly advertisement revenue, or a minimum guaranteed amount, whichever is higher.
 - The revenue share percentage or the minimum guarantee amount shall be proposed by the Advertising Agency as part of the financial bid.
 - Advertising Agency shall remit the Authority's share on or before the 10th day of every subsequent month.
 - The Advertisement Agency shall submit a monthly revenue report with certified billing statements of all advertisers, duration of ads, and slot utilization.
 - ASCDCL reserves the right to audit the revenue records at any time during the contract period.
 - The Advertising Agency will collect advertisement fees directly from advertisers.
 - No direct collection from ASCDCL will be applicable unless stated otherwise.

Eligibility Criteria:

- 1. Applicant must be a reputed company willing to work on a PPP basis.
- 2. Must be a Proprietorship company or registered under the Companies Act or Partnership Act in India
- 3. Must be operating in India for at least 5 years prior to the EOI release.
- 4. Must have at least 5 years of experience in outdoor advertising.
- 5. Average annual turnover should be at least ₹10 crore per year in the last 3 financial years (2022 to 2025).
- 6. Must have managed at least 50 outdoor hoardings / Unipole displays in one Indian city within the last 5 years.
- 7. Should have sufficient manpower, equipment, and financial capacity to execute the work.
- 8. Preference shall be given to CBC/ DAVP empaneled agencies for hoardings, billboard in Maharashtra.
- 9. Preference for companies having registered office at Chh. Sambhajinagar.





Submission Requirements:

Interested, qualified advertisement agencies are requested to submit their EOI along with the following documents in a closed and sealed envelope:

- 1. Covering Letter expressing interest.
- Company Profile, including past experience in any Government agencies which includes BOT or PPP projects.
- 3. Details of at least one previous project undertaken with documentary proof (Work orders, work client certificates and client contact details).
- 4. Financial capability documents- CA certified balance sheets, GST certificates, MSME certificates (if applicable), Banker certificate
- 5. Proposed methodology and approach for Licensing and maintenance.

- The % revenue collection to be shared with ASCDCL shall be minimum 5%, to be paid to ASCDCL on a monthly basis.
- There shall be an increase of 10% in the license fees every year after the completion of the first year from letter of allotment
- The qualified Proposals would be scrutinized based on the criteria mentioned herein. ASCDCL reserve right to invite price bid from qualified proposals received in response to this EOI or may invite open Bid also, for which Bid document/RFP will be issued separately.
