3. Maintenance and care of the plants for a period of 10 years, including watering, manuring, weeding, and replacement of dead saplings.
4. Implementation of scientific plantation techniques and sustainable practices.
5. Periodic reporting on plant survival and growth rate.
6. Shifting & replanting of large trees as instructed by ASCDCL & Chhatrapati Sambhajanagar Municipal Corporation (CSMC)
7. All the works needs to be completed as per the requirement of ASCDCL & Project Management Consultant appointed by ASCDCL.
8. ASCDCL will allow companies to installed “maintained by” board are location decided mutually.

Eligibility Criteria:

1. The applicant must be a reputed company willing to contribute under CSR funds.
2. Adequate manpower, machinery, and financial capacity to undertake the work.
3. Compliance with relevant environmental norms and government guidelines.
4. Preference will be given to organizations promoting sustainability practices.
5. ASCDCL is flexible to work with reputed companies willing to contribute under CSR funds.
